Who is VOICE?

VOICE (Virginians Organized for Interfaith Community Engagement) is a non-partisan citizens' organization of almost 50 faith and civic institutions in Northern Virginia. We organize to build power and do justice in middle and low-income communities in Fairfax, Prince William, Arlington and Alexandria City. Uniting people across lines of race, class, religion, political party and geography, we take action on key issues in our communities including, but not limited to, immigrant rights, foreclosure accountability, schools, criminal justice, affordable housing preservation/ development, and youth investment.

Founded in 2008, VOICE is an independent and non-profit organization led by a strategy team of religious, lay, and community leaders from across Northern Virginia. VOICE is funded by dues-paying member institutions (congregations, temples, mosques, union locals, business groups, schools, health centers, etc.), grants from foundations, and generous donations from individuals and businesses.

VOICE is affiliated with the Industrial Areas Foundation (IAF), the nation's first and largest network of multifaith broad-based citizen organizations, which has seven decades of experience winning tough battles on housing, health care, education, living wages, immigrant rights and other issues across the nation. VISION

We believe that people working together have the power to change their communities and their country for the better.

NEED

Political and corporate leaders often don't embrace change unless they're pressured by the people they serve. And too many people don't realize they have the potential to join forces and create change in their neighborhoods through organizing.

OUR APPROACH

We work with the people who want to transform the world—from what it is to what they believe it should be. We challenge people to imagine the change they can accomplish, connect individuals and organizations to multiply their power, and organize people by the hundreds and thousands to make their voices heard. We set bold goals, we create effective strategies—and we ACT, taking on the powerful interests that stand in the way.

VOICE Signature Victories

Held the CEOs from Bank of America, JP Morgan Chase, and General Electric accountable for the foreclosure crisis in Prince William County, VA — resulting in \$250 million in principal reduction, more than 1,500 loan modifications, and \$30 million in reinvestment capital that kept thousands of families from losing their homes and is rebuilding blighted communities.

Won \$800,000 to provide dental care to over 2,000 low-income adults in Northern Virginia and preserved \$9 million in state funding for dental care for low-income families statewide.

Trained and organized hundreds of immigrant leaders to win on local housing, recreation, youth investment and immigration issues as well as to be a voice on national comprehensive and accountable immigration reform.

Developed major power base of multi-faith institutions to support Muslims from hate and anti-immigrant based attacks.

Organized low-income tenants to preserve 1,000+ affordable apartments and public housing units from upscale development in Alexandria, Arlington, and Fairfax counties, to address housing and fire code violations, improving 2,000+ units in Fairfax, Prince William, and Alexandria, and to win 1,000+ new affordable housing units on public and non-profit owned land in Northern Virginia.

Secured \$3 million to renovate local parks and athletic facilities for low-income African-American and immigrant residents in southern Fairfax County.

Worked to secure over \$15 million in affordable housing projects in Arlington and Alexandria between 2017 & 2018.

Won \$10 million to expand pre-kindergarten to serve 576 low-income children in Prince William County, VA—the first majority-minority county in Virginia.

2018 Organizing Victories

Metro DC Transit Investment

At the October Action, Governor Northam recognized the work of VOICE and our Metro IAF sister organizations in Washington DC and Maryland, saying, “Thank you so much for what you have done. Because of your energy and what you did last year...Metro now has a dedicated source of revenue. Virginia put \$154 million a year on the table. Washington and Maryland followed suit. That is because of you.” This regional victory raised \$500 million per year for WMATA and is projected to yield \$15 billion in upgrades for transit infrastructure in the region.

Increasing Voter Engagement

More than 500+ Muslims, Jews, Christians, and Unitarians increased voter participation by 20%, notably more than the 14.38% in other District 10 Loudoun County precincts. VOICE leaders did strictly non-partisan Get-Out-the-Vote (GOTV) work door-to-door to get infrequent voters to the polls in the nationally watched District 10 midterm election.

Launched State Level Criminal Justice, Schools and Housing Campaigns

In 2018, VOICE launched a multi-year strategy to

- 1) Decrease mass incarceration including reforming cash bail.
- 2) Stop suspending driver’s licenses to punish low-income people who can’t afford to pay court fees. People need their cars to get to work and earn money to pay back the state. Currently, 600,000+ Virginians are affected by this draconian policy.
- 3) Increase the school counselor-to-student ratio back to 1:250, which would cost \$90M. The ratio in many elementary schools is now 1:500. Youth with access to mental health service providers in their schools are ten times more likely to seek care than others, and one in five have the need during their school years.
- 4) Raise the state’s contribution to its affordable-housing investment fund from \$7 million to \$20 million in 2019. Today, teachers, first responders, and other workers commute as long as two hours so they can live affordably.

Get Out The Vote

We met our goal - Over the course of 4 days, 507 VOICE leaders & 110 leaders from our sister affiliates in MD & DC knocked on doors, made phone calls, and received commitments to vote from infrequent voters.

The VOICE message at each door was simple-- "We are not here to tell you who to vote for, we just want you to vote. We know that when communities vote, politicians take notice. And, when they don't... communities often are neglected."

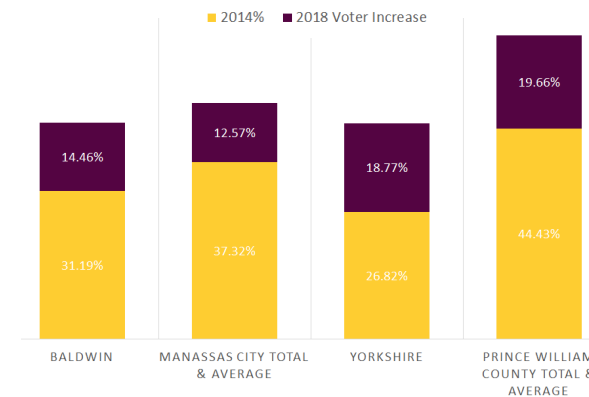
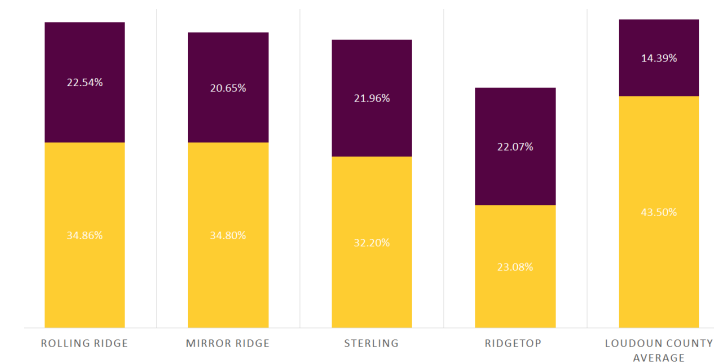
Knock on 5,651 doors of infrequent voters in low voter precincts in District 10;

Make 1,734 follow up phone calls to those infrequent voters;

Receive 2,322 commitments to vote on election day.

2018 Local Victories

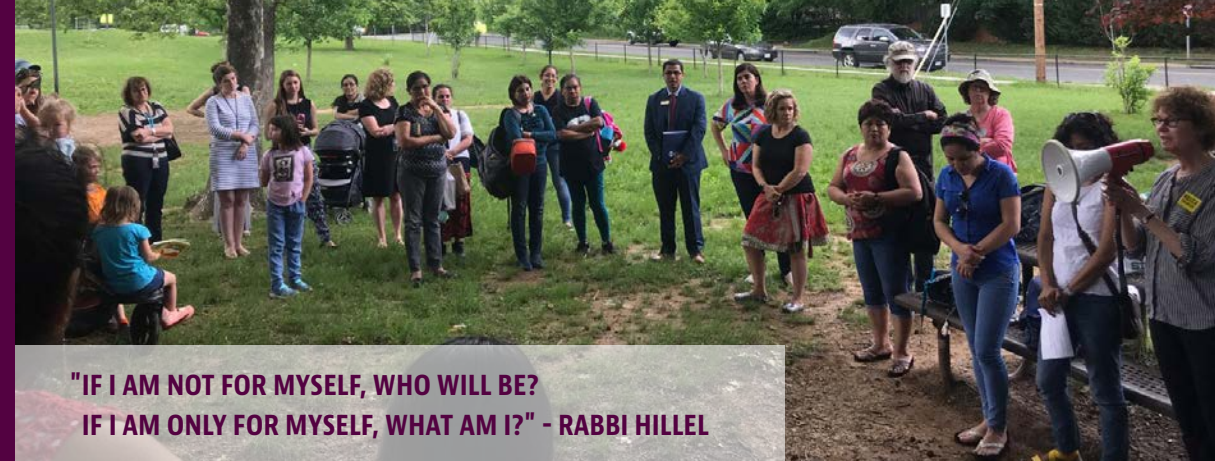
Alexandria City

- 1) Organized a non-partisan Get-Out-the-Vote campaign with public housing residents and doubled voter turnout in the precincts that are home to the most public housing residents.
- 2) Won \$4.3 million for affordable housing.
- 3) Got a commitment by the Mayor that public housing tenants will have oversight for the first time of public housing board appointments and new resident regulations.

Arlington County

VOICE moved the County to establish the APS Advisory Committee on Immigrant and Refugee Students, and in its first year it has:

- 1) Won clarification that the school system will accept a power of attorney to ensure that students can remain in their home school for the remainder of the year if parents are detained/deported.
- 2) That parents without US- or state-issued ID cards may obtain APS-issued ID cards to allow them to go into their children's school and participate in classroom activities.

Fairfax County

- 1) Led implementation of the school system's commitment to honor Muslim and Jewish holidays.
- 2) Won a commitment to restore bus service in a Vienna community where the loss of service is severely burdening children and older adults. Many residents there must walk more than a mile to the grocery store, the library, doctor's appointments, and jobs.



Prince William County

Won an additional 90 spaces for Pre-K programs – getting the total to 890 slots for low-income families with four-year olds; VOICE leaders added to their previous victory establishing public pre-K programs.



Metro 2018 KEY VICTORIES

ABOUT METRO IAF

VOICE is an affiliate of Metro IAF. The Metro Industrial Areas Foundation (Metro IAF) is affiliated with the Industrial Areas Foundation (IAF), the first and largest network of multi-faith, broad-based citizen organizations, which has seven decades of experience winning tough battles on housing, health care, education, living wages, immigration rights, and other issues in the US and abroad. Metro IAF's 22 affiliates are in the East, Midwest, and Southeast United States (CT, DC, IL, MA, MD, NC, NJ, NY, OH, VA, WI).

CRIMINAL JUSTICE REFORM

Won statewide Criminal Justice Reform in MA reducing use of mandatory minimums for drug sentencing, reduction of fines and fees for probation and parole, bail reform and regulating and reducing use of solitary confinement. 4,500 local leaders turned out for Fall 2018 accountability actions to push Governors, Mayors, Attorneys General, Congress people and Sheriffs for change on criminal justice reform in VA, CT, MD, NC, MA & IL. Secured commitments from VA Governor & Attorney General to make ending cash bail, raising the felony level, eliminating excessive court fees & fines and restoring drivers licenses for 654,000 Virginians central issues in the VA 2019 statewide elections.

HOUSING & NEIGHBORHOOD REVITALIZATION

Won \$2.2 billion to repair NYC Public Housing Authority (NYCHA) units where 500,000 black and brown New Yorkers live with mold, rats, no heat and many other code violations; Forced NYCHA to agree to tough new standards for fixing mold and leaks in the 186,000 units of NYCHA public housing. Secured \$500 million from NYC Mayor Bill de Blasio and City Council to begin construction on 15,000 senior units on vacant NYCHA land, which will free up NYCHA units to house 150,000 low income New Yorkers. Won \$250 million in dedicated funds for affordable housing in DC, MA, MD, NC & VA, which financed 9,590 units; Built/preserved through organizing 3,500 units of affordable housing in DC, IL, MA, MD, NC, NJ, NY & VA.

PUBLIC TRANSIT

Won \$500 million in new money annually to fund public transit infrastructure upgrades for the Washington Metropolitan Area Transit Authority (WMATA), which serves over 350 million transit riders a year, through a two-year campaign led by Metro IAF's 5 affiliates in the DC, MD & VA region and the Amalgamated Transit Union/ATU Local 689. Victory will yield \$15 billion in upgrades for transit infrastructure for the region and protects 13,000 living wage jobs for African American workers. Together the ATU-Metro IAF coalition resulted in: \$500 million dedicated funding deal without the threatened mandates of a federal control board, privatization, or destruction of frontline workers' retirement security.

GUN SAFETY

Do Not Stand Idly By (DNSIB), in partnership with Interfaith Center for Corporate Responsibility (ICCR), won shareholder victories at Sturm Reuger and American Outdoor Brands (AOBC) annual meetings requiring companies to issue reports on the deadly impact of their products and actions taken to mitigate those impacts. Partnered with nation's leading law enforcement officials: Houston Chief Art Acevedo and Montgomery County, MD Chief J Thomas Manger to publish op-ed urging AOBC to take action to reduce gun deaths. Briefed US Conference of Mayors on how to implement DNSIB gun manufacturer accountability standards. Pushed Federal Trade Commission to pull bump stocks from US Market.

STRENGTHENING LOCAL UNIONS

Trained 2,000 Amalgamated Transit Union (ATU) local union presidents, shop stewards and key leaders from 65+ locals across the US on creating and implementing strategies to engage and build power among workers who operate and maintain buses, trains and transit facilities. Metro IAF worked with each local to engage every member face-to-face, defend and create more middle class jobs, and organize riders to expand and improve public transportation. Metro IAF's efforts, supporting the visionary leadership of the ATU International, contributed to the largest membership numbers in the history of the ATU.

OPIOID CRISIS

Expanded access to evidence-based, life-saving Medication-Assisted Treatment (MAT) opioid addiction treatment on Long Island. Moved the largest hospital chains on Long Island to begin offering buprenorphine to opioid users in their emergency rooms; trained 100+ medical professionals in MAT; and won concrete commitments from Governor Cuomo and state agencies to remove barriers to MAT access in state-licensed treatment programs.



LIVING WAGE JOBS

Turnaround Tuesday/BUILD jobs movement in Baltimore secured 635 job placements through the organizing and training of unemployed, underemployed and returning citizens at Johns Hopkins Hospital and other anchor institution employers, with a 82% retention rate. Raised wages for DC Street Car, DC Circulator, Metro Access transit workers from poverty to living wages and benefits working with Amalgamated Transit Union ally Local 689. Won commitment from the Baltimore Mayor to make local hiring mandate a flagship policy of the city.

MENTAL HEALTH & YOUTH SUPPORT IN CRIMINAL JUSTICE SYSTEM

Created Crisis Intervention Team (CIT) training programs in Metro Chicago, training 1,101 law enforcement officers with 1,000 more in pipeline. Won creation of new Crisis Stabilization Units in Kane and Cook counties in IL to divert mentally ill people from jail to treatment. Won commitment from Manhattan District Attorney Cyrus Vance to push for the establishment of mental health diversion centers, and to expand CIT training for assistant district attorneys so that those with mental illness can avoid jail time and receive treatment instead.

IMMIGRATION

Secured pledges from law enforcement & school officials NOT to act as ICE agents in CT, DC, IL, MA, MD, NC & VA. Won commitments from Attorneys General in VA, MD, MA & DC to fight against family separations of US citizen children with undocumented parents and to oppose Federal actions to penalize immigrant families that use public services to which they are legally entitled. Won creation of parish ID's to be recognized by Baltimore City law enforcement and other agencies. Pushed schools officials in Northern Virginia to honor Muslim & Jewish holidays. Won \$5+ million in commitments to fund immigrant legal services in DC & MD.

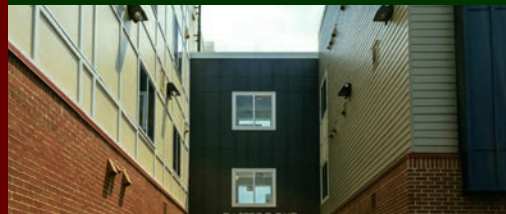


Started rehabilitation on 140 units of affordable housing in Ward 4 of the District of Columbia;

Completed, leased up 100%, 39 units of new construction affordable housing in Ward 7 of the District of Columbia;

Won a VISION Award for Historic Preservation of the House of Lebanon project. An Adaptive Reuse of the historic Margaret Murray Washington Vocational High school into affordable senior housing in Ward 5 of the District of Columbia.

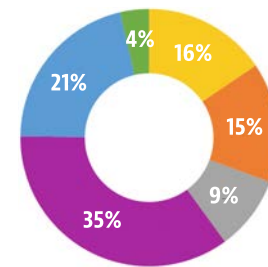
How We Are Funded

VOICE does not accept government funds so that it can remain autonomous and politically independent.

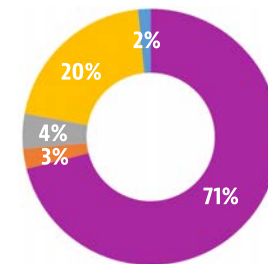
